Benefits & Fraud

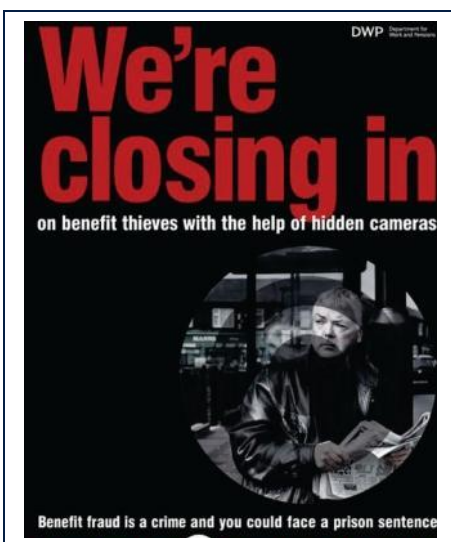
Fraud is the fastest growing area of crime in the UK and probably the modern World at the present time. Our enforcement agencies are ill equipped to deal with it and, consequently, vast amounts of fraud go undetected. In broad terms fraud is unlawfully obtaining somebody else's property, usually money, by some form of deception and can be facilitated in many ways. Some of the most common frauds are Bank Fraud, IT Fraud, Cheque Fraud, Prescription Fraud, False Accounting and Identity Fraud. The media are currently full of reports of vulnerable older people being defrauded out of their life savings and pensions.

Having spent 35 years in Criminal Investigation work and the last 14 years of my working life managing a Benefit Fraud Investigation Unit, today I am going to give a brief overview about Benefits and Fraud.

The Department of Work and Pensions (DWP) administer the Social Security Benefits system for the Government and billions of pounds of public money are paid out annually to claimants. Further vast amounts of public money are also used in administering the benefits

system which, in our modern caring Society, is invaluable as a safety net for all of us who may from time to time fall on difficult times.

It is paramount that benefit only goes to genuine claimants. Unfortunately, the unscrupulous in our society will always try to defraud the system and steal huge quantities of public money. In my time, it was generally accepted that about 10% of all benefits paid went out as the result of fraud and human error, although the largest amount was through fraud and I am sure that has not changed.



When we talk about Benefits, I refer to the likes of Housing and Council Tax Benefit, Employment Benefits such as Income Support, Job Seekers Allowance, and Tax Credits and the Health Benefits such as

Incapacity Benefit, Personal Independence Payments, and Attendance Allowance, to name but a few. Many Benefits are means tested so that it is important that claimants declare all their full circumstances correctly and also notify the DWP when they have a change in their circumstances. There is a declaration on all claim forms which must be signed to say that they will do this. Deliberate failure to do so is where the deception occurs and claimants receive benefits to which they are not entitled. Over a period of time this can run into thousands of pounds of public money.

Because all benefits have specific criteria to qualify for them, it usually requires a long and complicated claim form to be completed so that assessing officers have all the information necessary to ensure the claimant is getting the right amount of benefit. Unfortunately, claimants do not always have all the necessary information to hand and it takes time to get it. There is a lot of criticism in the press at present about the time it takes to administer benefits and this is usually the reason. Also, being awarded one type of benefit can be a gateway to being entitled to other benefits, which each require their own scrutiny.

In an attempt to simplify the process, the Government is trying to introduce Universal Credit (UC) to combine 6 different benefits with one on-line claims process but the complexity has been problematic and there are ongoing delays in rolling out this process. It is also proving to be very expensive.

Assessing Officers are clerical officers and not detectives; they do their best to identify suspicious claims and pass them to fraud investigation teams to pursue. The types of fraud most commonly encountered are:

- People claiming unemployment benefits when in fact they are working and failing to declare their income.
- People failing to declare all their savings and capital.
- People claiming they are a single parent or lone occupant when they have a partner living with them.
- People claiming that they are renting a property when in fact they own it.
- People claiming for levels of disability they do not have.

The list of types of benefit fraud is endless and all require appropriate evidence to prove

fraud to the satisfaction of the Courts.

In my opinion, the Courts are far too lenient with benefit fraudsters. They tend to view this type of crime as victimless as it is public money but they do not realise that it is Tax Payers' money, i.e. yours and mine. Claimants caught defrauding the benefit system, in theory, have to repay any overpayment but in practice very little money is recovered and most, eventually, gets written off as it is too expensive to pursue.

The benefits system is very complex and there are so many aspects to it that there is no simple way to streamline it. In my opinion, VAPP needs a team to specialise in understanding the full implications and complexities of the benefits system to be able to formulate clear policies on benefits and benefit fraud. Furthermore, VAPP also needs to consider how it will address the growing epidemic of fraud generally in society.

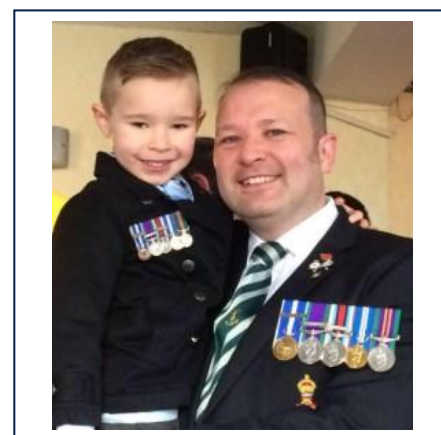
Like many veterans, I have served in Iraq, Afghanistan and with the United Nations, I can truly say my dedication to the UK is, and always has been, one of my top priorities.
